

The Specialized Literacy Professionals Service Project Grant

I. Grant Purpose:

Specialized Literacy Professionals (SLP) is a special interest group devoted to the needs and concerns of those with specialized training or responsibilities in literacy. We offer to our members an opportunity to apply for the SLP service project grant. One grant may be awarded annually and provides a maximum of \$500 to acquire materials and other resources for service projects supporting literacy development. The goals of this service project grant initiative are to:

- initiate, extend, or expand existing university-, school- and/or community-based literacy projects;
- support literacy-focused trainings for parents and other community members, and/or professional learning opportunities for teachers, specialists, and other school-based professionals /or parents;
- increase access, equity, and diversity efforts related to literacy instruction and/or literacy materials; and
- expand literacy intervention work.
- align grant work with the SLP mission (<http://www.literacyprofessional.org/>) and the 2017 Standards for the Preparation of Literacy Professionals (<https://literacyworldwide.org/get-resources/standards/standards-2017>)

II. Eligibility:

Applicants must be a member of the Specialized Literacy Professionals SIG.

III. Proposal:

Submitted proposals must include:

- A Cover Page
 - First and last name
 - Project title
 - Mailing address
 - Phone number and email address
 - Institutional affiliation and position/title
- Project Overview (*Maximum 1,000 words, excluding references and tables*)
 - Project title
 - Purpose, objectives, and the significance of the project and how the project aligns with the goals of the service project grant initiative (see Section I)
 - Sustainability of project post-funding
 - Proposed timeline
 - Proposed budget (include additional funding sources)
 - References

IV. Should your proposal be funded, SLP would expect the following:

- Your project must be completed within 18 months from the awarding of the grant
- You will submitted a deliverable after project is completed: narrated 3-5 minute presentation that will be posted on SLP website
- You will provide information about your project for the SLP biannual newsletter
- You must credit SLP for the funding of your project in any resulting publications

V. Review Procedures and Evaluation Criteria (Rubric):

Proposals will be scored by SLP board members through a blind-review process. The scores will be based on a scale of 1 (low) to 4 (high) in the categories included in the rubric.

VI. Submission
